

“Ultimate Summer Contest” CONTEST RULES & REGULATIONS

July 22-24, 2022

No Purchase Necessary to Enter or Win. Void where prohibited. Eligibility restrictions apply. All entries have an equal chance of winning. See below for Official Rules and complete details.

1. Eligibility

- a. Contest only open to individuals who complete “Ultimate Summer Contest” Contest Entry Form and are also residents in the Province of Alberta aged eighteen years or older.

2. How to Enter

- a. Automatically receive one Contest entry for completing the online entry form during the Contest Period. Only one entry per individual will be accepted for the duration of the Contest Period.
